## Social Membership Benefits Approved by the Board of Directors July 8, 2015

As a Social Member you are entitled to the following benefits:

- · Access to the Spójnia Credit Union.
  - The Spójnia Credit Union (SCU) is a member owned financial institution offering a multitude of financial services such as
    - Share Accounts (Savings)
    - Share Draft (Checking)
    - Share Certificates (Certificates of Deposit)
    - Vehicle Loans
    - Collateral Loans
    - Home Equity Loans
    - Online Banking
  - As a social member the PNU will make a one time \$5 deposit to your initial SCU account provided that a minimum of \$100 is deposited at the time the account is opened.
- Ability to utilize the New Born Benefit Program.
  - The program is designed to provide, free of charge, \$1,000 to a family of a registered child in the event of the passing of the child.
  - o The benefit covers a child from day six of life through six months.
  - o One parent must be a member.
  - The child must be enrolled in the program.
    - To enroll a parent must complete a simple one page enrollment form available through the Downloads Section of the PNU website.
  - The PNU also guarantees that a \$1,000 insurance policy will be issued in the name of the child regardless of medical conditions.
    - Minimum insurance benefits must be applied for in order for this provision to be applicable.
- Ability to apply for a home mortgage through the PNU. (Must be a member for minimum of Two Years and maintain membership for the duration of the loan)
- Guaranteed Issue of \$5,000 in life insurance coverage (plan of your choice) as a one application, one time, one per life benefit regardless of multiple enrollments. Issue age limits apply. Maximum issue age is 85.
- Access to the Straż, official publication of the Polish National Union of America.
