This application is not applicable for a Home Equity Loan. Contact Spojnia Credit Union for a Home Equity Loan Application. PROOF OF INCOME AND PLEDGE OF \$200.00 IS NEEDED FOR ALL SIGNATURE AND SCU SELECT LOANS.

The USA Patriot Act of 2001 requires Spojnia Credit Union to help the government fight the funding of terrorism and money laundering activities. Because of this federal mandate, we must obtain identifying information from you and verify the authenticity of that information before you can open an account with us or apply for a loan.

When you apply for a loan, we will ask for your name, address, social security number, date of birth, and other information that will allow us to identify you. We will also ask that you supply us with one form of a valid government issued picture identification. (Driver's license, passport, employer ID card) A credit report will be pulled for both applicant and co-applicant upon submission of application.

#### This application is valid for the following loans:

**Signature Loan:** Fill out the attached loan application. **Proof of income** is required for applicant. (Co-applicant) Maximum \$10,000.00. Terms up to five (5) years.

**SCU Select Loan:** Fill out the attached loan application. **Proof of income** is required for applicant. (Co-applicant) Maximum \$2500.00. Term up to 18 Months.

**New and Used Vehicle Loans:** Fill out the attached loan application. **Proof of Income,** Dealer purchase order (Bill of Sale) including purchase price, VIN, year, model, make and mileage of vehicle must be submitted with application. Proof of full coverage insurance and proof that Spojnia Credit Union is listed as loss payee are required. Terms up to six (6) years for new and used vehicles. Some restrictions apply as to the age of the vehicle.

**Used Vehicle Loan:** Purchased from an individual. Fill out the attached loan application. **Proof of income**, purchase price, VIN, year, model, make and mileage must be provided. Proof of full coverage insurance and proof that Spojnia Credit Union is listed as loss payee are required. Terms up to six (6) years. Some restrictions apply.

**Holiday/Vacation Loan:** Fill out the attached loan application and return with **proof of income.** Terms up to two (2) years.

**Collateral Loan:** Fill out the attached loan application and return with **proof of income**, title to vehicle and proof of full coverage insurance listing Spojnia Credit Union as loss payee. Proof of collateral is needed.

**Share Secured Loan:** Fill out the attached loan application and return to credit union. A hold is put on the shares in your account. If you are currently employed and working more than 25 hours a week, **proof of income** may be needed.

Other Titled Property (Recreational Vehicles) Loan: Fill out the attached loan application and return with proof of income. The certificate of title must list Spojnia Credit Union as lienholder. An insurance binder must be provided listing SCU as lienholder and must have adequate collision, comprehensive and liability coverage.

Home Equity Loan: Contact the credit union for an application.

Proof of Income: Paystub, Bank Statement showing direct deposit or W-2 Form must be provided by applicant and co-applicant (co-signer). If self-employed, 1099 forms and a copy of your current tax return are required. If supplying your tax return as proof of income, the taxpayer authorization and consent must be signed by all parties.

A pledge of \$200.00 is needed for all Signature and SCU Select Loans. A total of \$205.00 will be needed in your share account. \$5.00 for your share in Spojnia Credit Union and \$200.00 for the pledge. The pledge is released once the loan has been paid in full.

A copy of your current photo identification is requested for applicant and co-applicant.

Spojnia Credit Union participates in Electronic Lien and Title Service.
